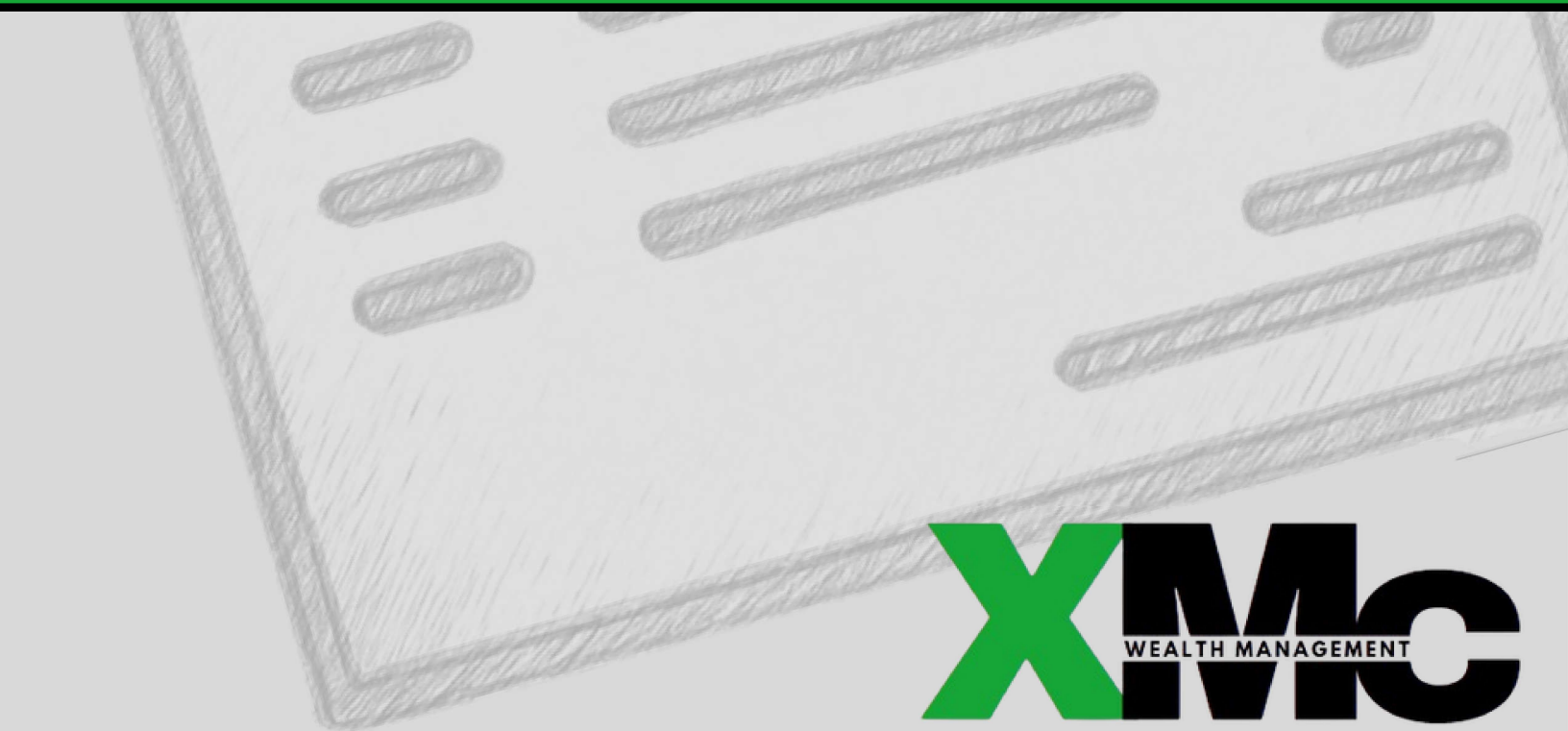

Bank account (Direct Pay)

Pay your tax balance due, estimated payments or part of a payment plan. Penalties and interest will continue to accrue on unpaid taxes.

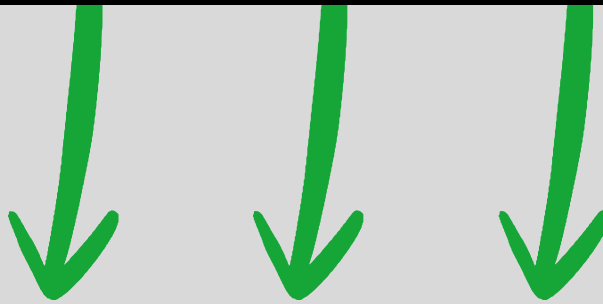
